## Social Security Number Trace + Address History

Verify names, aliases, and previous addresses of your candidate and validate the candidate's SSN matches legal names and aliases connected to any criminal records.

## National Criminal Databases Search

Searches databases from all 50 states, including digitized records from Department of Corrections, Administrative Office of the Courts and county courts.

## Federal Criminal Databases Search

Search U.S. terrorist lists, or expand the search to include Search across the 94 U.S. federal courts for violations of federal criminal law, such as tax evasion, fraud, embezzlement, identity theft, interstate trafficking, and kidnapping.

## 7-Year County Criminal Court Search
